



LOWE'S PRICES \$1.0 BILLION NOTES OFFERING

MOORESVILLE, N.C.--(BUSINESS WIRE)-- Lowe's Companies, Inc. (NYSE: LOW) announced today it has agreed to sell \$500 million of 3.80% Notes due 2021 and \$500 million of 5.125% Notes due 2041. Estimated net proceeds from this offering will be approximately \$991 million, after deducting offering expenses and underwriters' discounts. Lowe's intends to use the net proceeds from the notes offering for general corporate purposes, which may include repurchases of shares of our common stock, capital expenditures, acquisitions and working capital needs. Closing is expected to occur on November 23, 2011.

J.P. Morgan Securities LLC, Merrill Lynch, Pierce, Fenner & Smith Incorporated and SunTrust Robinson Humphrey, Inc. are acting as joint book-running managers for the notes offering. This offering was made under an effective registration statement on file with the Securities and Exchange Commission.
